1. THE FESTIVAL

In **OFestivalON** we don't miss an **F** as this is the **Five** edition. And again we want to keep our door opened to the rest of the world.

is an event dedicated to shorts and will be carried out in Galicia with many surprises in July and August.

2. AIMS

OFestivalON basic aim is the diffusion and promotion of short films throughout screenings. It's about promoting a product that it's usually not well treated by all the cinematographic windows, as well as offering the chance to big audiences to watch short films screenings in an exceptional environment and to meet filmmakers.

3. REQUIREMENTS

- The participation in this Festival is open to all the producers and filmmakers; they may enter as many films as they wish.
- Short films with the year of production 2008 and 2009 will be accepted. They can not be longer than 20 minutes, please!
- The criteria of selection will be the quality and originality of the short films and never the original shooting format.
- The short films will be presented in original version. The non Galician or Spanish spoken language short films should have Spanish or Galician subtitles or a dialogue list with timecode in SRT, SSA or STL format and in English or Spanish, in order to introduce them in the projections.

4. CATEGORIES

The official competing categories are:

- Live Action Short Films.
- Animation Short Films.
- Documentary Short Films.

5. REGISTRATION

The registration and participation will be effective sending to the Festival the following materials:

- Copy of the short film in DVD, good one that doesn't fail in its reading!
- Completed entry form.
- A CD-ROM which will include: at least 3 stills from the short film, synopsis and technical and artistic sheet, also all the information you may consider important.

It can be admitted or requested by the organisation films in Betacam or DV format. Anyway with the same conditions said before; It will never be requested film format.

The copy of the short film will be identified with title, producer company and name of the author/s or representative.

All the requirements have to be submitted to the organisation earlier than the 15th of May 2009 (date of postmark):

The Festival Organization organisation assumes that the sender of the short film (person or production company) has got all the exhibition rights of the short film, as well as the authorisation to receive the prize in case the jury awards his short film.

The organisation does not have any responsibilities if this rule is broken by the sender.

6. SELECTION

A selection committee appointed by the organisation will select, from all the short films received, the short films that will enter the competition; the decisions of this committee are not appealable. When this process is finished the decision will be communicate to the participants selected.

The short films selected will be screened during the festival in the squares and cinemas set by the organization; the schedule, order and date will be established by the organisation.

7. PRIZES AND JURY

- ***Misto de Pau de Sabugueiro*** for best Live Action Short Film 1200,00 €
- ***Misto de Pau de Carballo*** for best Documentary Short Film 1200,00 €
- ***Misto de Pau de Castiñeiro*** for best AnimationShort Film 1200,00 €
- ***Misto de Pau de Loureiro*** for best Short Film Audience prize 1200,00€

The Jury will be composed of professionals in the film and cultural industries. The decision will not be appealable and will be published through the festival official web, the media, and by phone and email to the winners.

8. REDECURTAS 2008 PROGRAM

- Mr Misto Films promotes since 2003 the REDECURTAS – Mr MISTO SHORTS program, all the Short Films received will be included in this program and will be screened in different villages.
- The program exhibition places are: cafes, auditoriums, cultural arts centers, squares, public places and educational centers
- Each Short Film will be paid between 6,00€ and 12,00€ (Spanish VAT included) for each screening within the program.
- The producer will receive a report by mail which includes all the information about his short film screenings and the money owed at the end of the year; in order to get this money paid it's necessary to send the invoice to Mr Misto Films (to de address above).

- The royalties management and everything in relation with Mr MISTO SHORTS program will be available to be followed after the OFestivalON dates in the web site www.mrmisto.com/shorts.
- The duration of the program is 1 year, starting the day Mr Misto Films gets the completed entry form; this duration can be extended before the end of the year if the two parts agree.
- To participate in this program is completely compatible with any other typical frames of distribution: other festivals, tv, internet, etc. It means: it is not exclusive. The producer is free to dispose.

9. GENERAL RULES

- The cost of dispatching the copies to the Festival will be paid by the sender.
- The producers of the selected short films authorize the use for promotional and information purposes of the materials provided (pictures, synopsis...) and up to 2 minutes of the short films.
- Registering to the **OFestivalON** implies full compliance of these requirements, rules and regulations by the participants, as well as the solutions given by the organization to any problem not included in the requirements.
- These regulations are printed in Spanish, English and Galician. If any doubt in interpretation arises, the Galician version will be considered valid.
