### Agreement and Disclaimer:

I submit this film with the understanding all licensing, clearance, and copyright is my sole responsibility. I represent and warrant that I am the filmmaker of the enclosed film; that I am the present and sole owner of rights, title and interest in and to said film; that I have the exclusive unconditional right and authority to submit said film to the Royal Flush Festival (referred to herein as "RFF") upon the terms and conditions set forth herein; and that no third party is entitled to any payment or other consideration as a condition for the use of said film as set forth herein. I will indemnify and save the RFF harmless from any and all claims, expenses, losses or liabilities that may be asserted against or incurred by the RFF at any time in connection with the use of said film, including without limitation, those arising from any breach or alleged breach of the warranties and promises given by me herein, including reasonable attorneys' fees and other costs incurred defending against the same.

I understand that submitting this film to the RFF and/or presentation of the film to the public by the RFF will expose the film to others and hereby specifically release the RFF from any and all liability, direct or indirect, resulting from the improper use by any other persons or entities of any similar ideas, formats, stories, suggestions and the like relating to said film.

I understand the RFF makes every effort to handle entries with the utmost care. I have retained at least one copy of said film and release the RFF from any and all liability for loss or other damage to copies of said film submitted to the RFF hereunder.

In the event of any dispute concerning said film or concerning any claim of any kind or nature whatever, arising in connection with said film or arising in connection with this release form, such dispute will be submitted to arbitration. Each party hereby waives any and all rights and benefits which s/he or it may otherwise have or be entitled to under the laws of any state in the United States of America to litigate any such dispute in court, it being the intention of the parties to arbitrate all such disputes according to the provisions hereof.
